Why the Delays in Children Receiving Needed Durable Medical Equipment and Supplies?



Editor's note: Given the strong interest in this report, published in the May 10 newsletter, we are repeating it. Families and health care providers frequently report lengthy delays in obtaining essential supplies and equipment for children with special needs, sometimes with severe consequences for the child's health and development. A new report outlines the multiple administrative obstacles that contribute to these delays, and offers recommendations on how to address them. Study: How Pediatricians View Caring for Children with Special Health Care Needs

A large proportion of California children with special health care needs are cared for by primary care pediatricians, who face numerous challenges in providing appropriate services. A new study, published in the Maternal and Child Health Journal, assesses who is providing medical care to CSHCN in California, how providers differ in the types of patients and conditions they treat, and the level of pediatricians' access to subspecialty and practice resources. The authors discuss factors that might improve pediatricians' capacity for caring for CSHCN. Funding was provided by the Lucile Packard Foundation for Children's Health. Read the study.

Addressing Children's Mental Health Needs

May is Mental Health Awareness Month, a time to note that many children with special health care needs also require mental health services. Yet a 2017 survey of families and care providers by the National Health Law Program identified mental health treatment as one of the most difficult services for CSHCN to obtain. Similarly, respondents in a 2015 survey of pediatricians who care for CSHCN described great difficulty in making successful referrals for pediatric psychiatry and psychology services. The California Legislature has proposed several bills that address children's mental health. Two current bills are worth noting.
