From Family Voices: Tool Measures Level of Family Engagement, Offers Ideas for Enhancement

Though there is much agreement on the value of family involvement at the systems level of health care – where policies, programs, and services are created or changed – it is still rare for families to have more than a token amount of power and influence. A new issue brief from Family Voices provides a framework, featuring four domains and specific criteria, that organizations can use to measure and improve the level of family engagement in their work. CCS Advisory Group Addresses Specialty Care, Other Whole-Child Transition Issues

On April 4, members of the CCS Advisory Group questioned state representatives on a range of subjects related to the upcoming transfer of some CCS children into Medi-Cal managed care, including the availability of pediatric specialty care in the selected counties, the future of coverage after the first year of transition, and family engagement with the plans. CalOptima, one of the managed care plans, made a presentation on how it is addressing stakeholder engagement. See the <u>agenda and slides</u> from the meeting. The state also has sent and posted the <u>90-Day Notice</u> (PDF) to families that explains how the transition will work and answers frequently asked questions.
