Take a Survey: Help Improve Well-Being of Families Who Care for Children with Health Complexity

Parents, guardians, siblings, or other family caregivers of a child with complex health issues are invited to complete a short survey to help researchers better understand how to improve family well-being. The study, funded by our Foundation, is being conducted by a team of family leaders, clinicians, and researchers from the CYSHCN National Research Network. The team seeks to document what day-to-day life is like for families, with the goal of developing recommendations on how the health care system can improve family well-being. Report: The Future Pediatric Subspecialty Physician Workforce

Pediatric subspecialists are critical to ensuring quality care and conducting research to improve prevention, diagnosis, and treatment, but there are substantial disincentives to pursuing a career as a pediatric subspecialist. A report from the National Academies of Sciences, Engineering, and Medicine recommends strategies and actions to ensure an adequate pediatric subspecialty physician workforce to support broad access to subspecialty care and a robust research portfolio.
